released, and by these presents do grant, bargain, sell and release unto the said *L. C. Ashmore*

all that piece, parcel, tract or lot of land situated in *Gantt*

Township, Greenville County, State of South Carolina, *on the east side of the Park Shoals*

Road, about eight and a half miles from the City of

Greenville, having the following metes and bounds
