WHEREAS, *R. B. Glazener*

am well and truly indebted to *Silva J. McKinney*

in the full and just sum of *three hundred sixty five 00/100*

Dollars, in and by certain promissory note in writing, of *27th* day of *April* 192*7*

day of *April* 192*7* in *Atlantic City, N. J.* in full payment of *five* hundred *and* no/100 dollars, which said sum of *five* hundred *and* no/100 dollars, to be due and payable *to* *Silva J. McKinney* with interest from *April* 192*7*

at the rate of *eight* per centum per annum until paid; interest to be computed and paid annually, and if unpaid when due to bear interest at same rate as principal until paid, and I

have further promised and agreed to pay ten per cent. of the whole amount due for attorney's fees if said note be collected by an attorney or through legal proceedings of any kind, reference being hereunto had will more fully appear.

NOW, KNOW ALL MEN That I, *R. B. Glazener*

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof according to the terms of the said note, and also in consideration of the further sum of Three Dollars to me

in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said *Silva J. McKinney*

all that piece parcel, tract or lot of land situated in *Greenville*

Township *Greenville* County, State of South Carolina,

*at a short distance without the corporate limits of the City of Greenville, being a portion of lots Nos. 27 and 28 of a plat of same, done by Silva J. recorded in R. B. C. Office for Greenville County in Plat Book A, pages 510 and 511, and having the following meter and bounds: Beginning at a stake on the west side of Brockman Avenue at corner of lot No. 28, and running thence with line of lot No. 28 said 21, 71, 57-25 W. 110 feet to stake; thence S. 32-53 W. 42 feet to stake; thence S. 57-35 E. 125.9 feet, more or less, to stake on Brockman Avenue; thence with Brockman Avenue N. 10-35 E. 35 feet to the beginning corner.*

*Also that other lot of land in the County and State aforesaid, adjoining the above described lot, and being a part of lot No. 28 as shown on plat recorded in Plat Book A, pages 510-511, and having the following meter and bounds:*

*Beginning at an iron pin on Brockman Avenue intersecting corner of lot 27 and 28 and running thence along line of lot 27 N. 57-25 W. 98 1/2 feet to intersection corner of lots 28 and 21; thence in a southerly direction to a point on Brockman Avenue 76 feet distant from intersection of Brockman Avenue and McColl Street; thence with Brockman Avenue 15 feet to the beginning corner.*
