with interest thereon, from *date* at the rate of *8* per cent. per annum to be  
computed and paid *annually*

until paid in full, all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or  
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who  
may sue thereon and foreclose his mortgage, said note further providing for an attorney's fee of

*Twenty five Dollars* besides all costs and expenses of collection, to be added to  
the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part  
thereof be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference  
being thereunto had, as will more fully appear.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do

grant, bargain, sell and release unto the said *J. Lee Greene*

All that certain piece, parcel or lots of land situate just outside the Corporate limits of  
the City of Greenville, County and State aforesaid and known and designated as lots Number  
Ten (10) and Eleven(11) in Block E., in plat of survey of land of W.N. Norwood, known as  
"Norwood Heights", made by W.D. Neves, Surveyor and recorded in the office of the Register  
of Mesne Conveyances for Greenville County in Plat Book E., pages 215 and 216.

Said lots having a frontage on Vance Street of twenty-five feet each and a depth of One  
hundred and fifty feet, more or less, to the lands of the Woodside Mill Company.

Also all that other lot or lots of land situate just outside the Corporate limits of Greenville  
City, in the State and County aforesaid and known and designated as lots Nos. eight (8) and  
nine (9) in Block E, in plat of survey of land of W.N. Norwood, known as "Norwood Heights"  
made by W.D. Neves, Surveyor, bearing date of March 1920 and recorded in Register of Mesne  
Conveyance's office for Greenville County in plat book E, on pages 215 and 216.

Being the same land conveyed to Minnie L. Burden by W.N. Norwood by deeds dated Jan. 17th,  
1921 and December 27th, 1921 and conveyed to the grantor by the said Minnie Lee Burden by deed  
dated December 30th, 1922.

This mortgage is subsequent and subject to prior liens of the following mortgages, Minnie L.-  
Burden to F.H. Earle, \$1,000. - Minnie L. Burden to J.K. Earle \$250.00 - American Building  
and Loan Assn. \$1000.00, -J.L.W. McCracken \$115.00 .
