WHEREAS, I, the said R.W. Bridwell

in and by R.L. Ford certain promissory note, in writing, of even date with these presents, am well and truly indebted to

in the full and just sum of Six hundred fifty one & 5/100 Dollars, to be paid \$325.83 due one year from date, \$325.84 due two years from date

with interest thereon, from date at the rate of 8 per cent per annum to be computed and paid annually

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of

ten per cent besides all costs and expenses of collection, to be added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereunto had, as will more fully appear.

at and before the signing of these Presents, the receipt hereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do

grant, bargain, sell and release unto the said R.L. Ford that certain piece, parcel or lot of land

situate, lying and being in the State and County aforesaid in Chick Springs Township near the Town of Greer on the West side of the National Highway and having the following metes and bounds, to-wit:

Beginning at a stake on the Street leading from the National Highway to Carlton Store and runs thence S. 87-50 W. 170.5 feet to a stake on line of lot No. 11; thence S. 8-27 W. 84 feet to a stake corner of lot 4 and 5; thence S. 87-50 W. 140 feet to a stake corner of Lot #2; thence N. 8-27 E. 88 feet to old National Highway; thence with said old Highway N. 54-54 E. 234.2 feet to a stake on said highway corner of lot #10; thence N. 87-50 E. 165.5 feet to new street running from New National Highway to Carlton Store; thence with said new Street S. 16-47 W. 140 feet to the beginning corner, and being lots Nos. 8, 9, 11 and 12 on a plat of land known as R.L.
