WHEREAS, *I*, the said *Manning W. Jones*

Dollars, to be paid *February 1st 1924* *with interest*
payment, wholly or in part *privilege of anticipation*

this 10th day of May 1923

with interest thereon, from *the 10th day of May 1923* at the rate of *8* per cent. per annum to be
computed and paid *until paid in full*

until paid in full; all interest now due to bear interest at the same rate principal; and if any portion of principal or
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due at the option of the holder hereof, who
may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of *three dollars* besides all costs and expenses of collection, to be added to
the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part
thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference
being thereunto had, as will more fully appear.

NOW KNOW ALL MEN, That *I*, the said *Manning W. Jones*
in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said *Louise G. Harris*

according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to *me*, the said *Manning W. Jones*
in hand well and truly paid by the said *Louise G. Harris*

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do
grant, bargain, sell and release unto the said *Louise G. Harris, her heirs and assigns*

All that certain piece, parcel or lot of land situate, lying and being in Greenville
County, State of South Carolina and being known and designated as a part of Lots #4 and #5
on a plat of the McDaniel Property, said plat being recorded in the R.M.C. Office for
Greenville County in Book "E" at page 218, and being more particularly described as follows:
Beginning at a point on the West side of Augusta Road, 513 feet from the property of
Mrs. Sullivan, and running thence with said road in the direction of the City of Greenville
a distance of 122-1/2 feet to a point on Augusta Road; thence S. 60-42 W. 800 feet, more or
less, to the old Augusta Road; thence along the line of said Road in a Southerly direction
162-1/2 feet, more or less, to a point; thence N. 60-42 E. 877-1/2 feet, more or less, to the
point of beginning on the Augusta Road, and being the same lot of land conveyed to me, the
said Manning W. Jones by C.P. Simmons and J.R. Moran by their deed dated January - 1923.
