SEND GREETING:

WHEREAS, *me*, the said *T.F. Williams and C.L. Morgan*
in and by *H.B. Tindal* certain *to* note in writing, of
even date with these presents, *well and truly indebted to*

in the full and just sum of *One Thousand and no/100*
Dollars, to be paid *one year after date*

with interest thereon, from *date until paid* at the rate of *Eight* per cent. per annum to be
computed and paid *semi-annually*

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who
may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of *ten per cent on amount due*
besides all costs and expenses of collection, to be added to
the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part
thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference
being thereunto had, as will more fully appear.

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said *H.B. Tindal*

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do
grant, bargain, sell and release unto the said *H.B. Tindal, his heirs and assigns*

H.B. Tindal, his heirs and assigns: All that certain piece piece, parcel or lot of land
situate, lying and being on the north-east side of the Buncombe Road about 2-1/2 miles
from Greenville Court House, in the County of Greenville and State of South Carolina, on
what is known as Williams Street, as shown on plat recorded in Vol. "NNN" of deeds at page
485, and designated as Lot No. 9, thereon and having the following metes and bounds, to-wit:
Beginning at the corner of lot No. 10 and running thence with Williams Street S. 21.20 E.
70 feet to Hudson Street; thence with Hudson Street N. 59-1/2 E. 210 feet to corner on Wright
Street; thence with Wright Street N. 21.20 W. 70 feet to corner of lot No. 10; thence with
