SEND GREETING:

WHEREAS, I, the said Mrs. Katie C. Pride  
in and by my certain promissory note in writing, of  
even date with these presents, am well and truly indebted to

in the full and just sum of Six Hundred and no/100  
Dollars, to be paid Six months after date

with interest thereon, from maturity at the rate of 8 per cent. per annum to be  
computed and paid semi-annually

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or  
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who  
may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of ten per centum

besides all costs and expenses of collection, to be added to  
the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part  
thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference  
being thereunto had, as will more fully appear.

NOW, KNOW ALL MEN, That I the said Mrs. Katie C. Pride  
in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said  
Farmers Loan and Trust Company  
according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do  
grant, bargain, sell and release unto the said Farmers Loan & Trust Company.

All that certain piece, parcel or lot of land situate  
lying and being in the state of South Carolina,  
County of Greenville and in Greenville Township in  
the vicinity and near the eastern limits of the  
city of Greenville, and known and designated as  
lot number thirty seven of the Querkbrook Land  
Company, according to a map or plat of said  
Querkbrook Land Company's property, recorded in the  
R. M. C. office for Greenville County, South Carolina  
in Plat Book "C" at page 224, said lot of land being  
described by meter and bounds as follows, to-wit:

Beginning at a pin on the east side of Spruce  
street Two Hundred Twenty feet from the corner  
of North street, and running thence North 64 degrees,  
59 min, East Three Hundred Twenty-four and 7/10  
feet to a pin; thence South 35 deg. 26 min. East Forty  
five to a pin; thence South 56 deg. 23 min; West, Two  
hundred ninety-eight and 3/10 feet to a pin on Spruce  
street; thence with said Spruce street North 47 deg.
