in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said Taylors Lumber Company

according to the terms of the said note, and also in consideration of the further sum of The Dollars, the said B. F. Goodwin

in hand well and truly paid by the said Taylors Lumber Company

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Taylors Lumber Company, all that lot,

parcel, or piece of land lying along the waters of Mountain Creek on the north side waters of Enoree River known as the La Fayette Barton Land. Being a part of the same tract conveyed by deed by J. F. Freeman to W. P. Southern and having the following described and bounds and containing 14 and 38/100 acres, more or less; according to a survey made by J. Earle Freeman March 1st, 1924: Beginning at an iron pin on the north side of Mountain Creek; thence N. 80 1/2 W. 4.96 chains to stone near Highway leading to Taylors; thence N. 36 W. 2.17 to iron pin in old road; thence N. 66 1/4 E. 23.10 to iron pin; thence S. 70 3/4 E. 4.74 to stone at cotton house; thence S. 29 3/4 W. 6.42 to stone; thence S. 69 1/4 W. 1.04 to stone; thence S. 51 1/4 W. 3.82 to stone on north bank of Mountain Creek thence along said Creek to beginning corner.
