WHEREAS, I, the said W. D. Workman

in and by my certain Promissory note in writing, of even date with these presents, am well and truly indebted to Peoples Bank of Fountain Inn, a Corporation under the laws of the state of South Carolina in the full and just sum of Seven Hundred and Fifty

Dollars, to be paid Jan. 31st 1925

with interest thereon from Jan. 31st 1924 at the rate of 8 per cent. per annum, to be computed and paid semi-annually

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place, and the holder should place, the said note or this mortgage in the hands of an attorney for any legal proceedings, then in either of said cases the mortgagor promises to pay all costs and expenses, including 10 per cent. of the indebtedness and attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

Assigns; All that certain lot of land in Greenville Township, State and County aforesaid, near the Corporate limits of the City of Greenville and being known and designated as lot no. 17 on plat of property of Slattery and Henry, Inc. (June 20th, 1922) and being more fully described as follows: Beginning at an iron pin on the South side of Reedy Street, 210 feet east of Parker Road and running thence with Reedy Street N. 63 E. 60 feet to an old iron corner, corner of property of Southern Power Company; thence with line of Southern Power Co. S. 28 40 E. 306 feet to an iron pin in line of lot no. 5; thence with line of lot no. 5 S. 63 W. 39 feet to an iron pin, corner of lots nos. 16 and 17; thence with line of lot no. 16, N. 32-10 E. 308 feet to the beginning corner.
