*the north side of East Park Street, beginning at a corner pin on the north side of East Park Street, which pin is 65 feet and 4 inches from the northwest corner of Charles and Bennett streets and running thence with East Park Street in a westerly direction 65 feet 4 inches to pin; thence in northerly direction in line parallel with Bennett Street about 150 feet to pin on line Avenue; thence with line Avenue in easterly direction 65 feet 8 inches to pin; thence in southerly direction about 140 feet to beginning corner; being lot no. 17 of Section 7 of Stone Land Company, recorded in Plat Book A, pages 337 to 345.*
