have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Citizens Building and Loan Association, of Greer,
Greenville County, South Carolina, all that lot of land in said State and County, in the City of Greer, on the *north*

side of *Emma* Street.

Beginning at a stake at the intersection of Emma street and a new street recently opened between this property and the E. D. Green property and which extends from the said Emma street to church street, and runs thence east approximately 40 feet with the said Emma street to a stake; thence north approximately 140 feet to a stake on an alley; thence with said Alley west approximately 40 feet to a stake on the said new street; thence with this new street south approximately 145 feet to the beginning corner and being a part of the B.
