PROVIDED ALWAYS, NEVERTHELESS, and it is the true intent and meaning of the parties to these Presents, that if I the said mortgagor, shall well and truly pay, or cause to be paid, unto the said Citizens Building and Loan Association, of Greer, Greenville County, South Carolina, its certain Attorney, successors or assigns, the said debt or sum of money aforesaid with interest thereon, if any shall be due, according to the true intent and meaning of the said Bond and Condition thereunder written, then this deed of bargain and sale shall cease, determine and be utterly null and void; otherwise, it shall remain

in full force and virtue. And it is agreed, by and between the said parties, that the said mortgagor his Heirs, Executors or Administrators, shall and will insure the House and Buildings on said lot in the sum of not less than \$ Eighteen Hundred
