All that piece parcel or lot of land situate in the City of Greenville, County and State aforesaid, and described as follows:

Beginning at an iron pin on Augusta Street, corner lot of Mrs. Minnie E. Davis, and runs thence S. 14 1/2 E. 5 1/2 feet with said Street; thence N. 80 1/4 E. 15.0 feet; thence S. 10 1/2 W. 50 feet; thence S. 80 1/2 W. 150 feet to the beginning.

Also all that other lot of land situate in the City of Greenville, County and State aforesaid, and described as follows:

Beginning at an iron pin at the rear of the Western corner of lot 5 and 6, on a plat of West End Land & Improvement Co., and runs thence S. 74 W. 65 feet; thence N. 11 W. 50 feet; thence N. 79 E. 65 feet; thence with rear line of lot 6, S. 11 E. 50 feet to the beginning corner.
