WHEREAS, I, the said Claude Carlton

in and by my certain promissory note in writing, of even date with these presents well and truly indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation incorporated under the laws of the State of South Carolina, in the full and just sum of Seventy Five Hundred and No/100 Dollars, to be paid on or before the date when the 5, 6, 12th Series of the said Association

Stock of the said AMERICAN BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent. per annum, payable weekly on or before Saturday night of each and every week until paid in full; and if I

NOW, KNOW ALL MEN, That I, the said Claude Carlton

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said AMERICAN BUILDING AND LOAN ASSOCIATION, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to the said Claude Carlton

in hand well and truly paid by the said AMERICAN BUILDING AND LOAN ASSOCIATION at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said AMERICAN BUILDING

AND LOAN ASSOCIATION All that lot of land situated in the West End City of Greenville, State and County aforesaid, and having the following metes and bounds, Viz: Beginning at an iron stake corner of Henry Means' land and running with said Means' line 165 feet southeast to corner of George W. Sloan's lot; thence with said George W. Sloan's line 135 feet northeast to an iron stake corner of Robert Scott's lot; thence with Robert Scott's line northwest 165 feet to street; thence with said street southwest 165 feet to street; thence with said Street southwest 135 feet to beginning corner, containing one-half (1/2), acre, more or less.
