And we agree to insure the house and buildings on said lot in a sum not less than _____

Dollars, in a company or companies satisfactory to the mortgagee and keep the same insured from loss or damage by fire, and assign the policy of insurance to the said mortgagee; and in the event that we shall at any time fail to do so then the said mortgagee may cause the same to be insured in their name and reimburse itself for the we expense of such insurance with interest under this mortgage.
