All that piece, parcel or lot of land lying in Greenville, Township Greenville, County Greenville, South Carolina about two miles from Greenville, South Carolina near the corner of Arden Street and North Street being a portion of lots Nos 73 and 74 on Plat of Arden Street recorded in office of R. M. C. for said County in Plat Book 4, page 42, and having the following metes and bounds: Beginning at an iron pin on the North side of Arden Street corner of lot No 72 (which pin is 25 38 feet from the intersection of Arden and North Streets) and running thence with line of lot No 72 N. 64-30 W. 100 feet to stake corner of lot No. 75 thence with line of lot No. 75 N. 64-30 E. 70 feet to stake thence S. 25-38 E. 100 feet to stake on Arden Street; and thence with Arden Street S. 64-30 W. 70 feet to the beginning corner being the same conveyed to me by H.
