Jackson*

in hand well and truly paid by the said AMERICAN BUILDING AND LOAN ASSOCIATION at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said AMERICAN BUILDING AND LOAN ASSOCIATION

All that piece parcel or lot of land in Greenville Township, near the City of Greenville, Greenville County, State of South Carolina and lying situate and being on the West side of Jones Avenue and being known and designated as Lot No. 38, upon a plat of "Crescent Terrace" said plat recorded in office of Registrar of Deeds for Greenville County, South Carolina in Plat Book "6" page 129 and having the following metes and bounds; to-wit:-  
Beginning at a point on Jones Avenue, joint corner, lots 37 and 38, and running thence along line of lot No. 37 N. 24.10 W. 33.7 feet to lot No. 35, thence along the line of lot No. 35 and lot No. 34 S. 3.18 E. 40 feet to lot No. 34, thence along the line of lot No. 34 S. 84.10 E. 33.4 feet to Jones Avenue, thence along Jones Avenue N. 50 E. 71 feet to the beginning point.
