situate, lying and being in Greenville township County and State aforesaid, near the City of Greenville, known and designated as lot No. 18 of the sub-division known as Augusta Circle and shown on a plat of record in the R. C. office for Greenville County, South Carolina, in the plat book "4" page 23, and having according to said plat, the following meters and bounds, to wit: Beginning at an iron pin on the north side of Augusta Drive East, joint corner of lots of nos. 18 and 19, and running thence with line of lot No. 19, N. 21-35 E. 149.8 feet to an iron pin in the rear of lot No. 2; thence N. 60-14 W. 50.5 feet to an iron pin; thence S. 21-35 W. 155.6 feet to an iron pin on the N. side of Augusta Drive East; thence with said Augusta Drive East 50.1 feet to the beginning corner.
