and released, and by these presents do grant, bargain, sell and release unto the said Julia D. Charles

all that piece, parcel, tract or lot of land situated in Greenville
Township, Greenville County, State of South Carolina, Known as lots nos. 1, 2, 6, 7 and 8,

in Block D, on Plat of Property of Julia D. Charles,
recorded in office of R. M. C. for said County in Plat
Book E, Page 209, also 28 feet cut from the eastern side
of Lot 10 in Block D on said Plat. Lots 1 and 2 have a
frontage of 80 feet each on the north side of Eastly
Bridge Road, lots 6 and 8 having a frontage of 80 feet
each on the east side of Washington Avenue and
lot 7 has a frontage of 80 feet on the west side of
Texas Avenue. Reference to said Plat is craved for
a more particular description.
