Cruikshank, Guardian for Sarah Cruikshank and Ray Cruikshank* all that piece, parcel, tract or lot of land situated in *Greenville*

Township, Greenville County, State of South Carolina, *about 1-1/2 miles east of Greenville Courthouse, on the Old Spartanburg Road: Beginning at an iron pin on the north side of Old Spartanburg Road, corner of property of Parker Land Company; thence along said road N. 65-45 W. 543.5 feet to iron pin in center of road projected; thence along line of Mrs. W.W. Burgess property N. 44-22 W. 53.5 feet to iron pin, corner Mrs. Burgess property; thence along line same property N. 45-47 E. 772 feet to iron pin; thence S. 46-08 E. 37.1 feet along same property to an iron pin on line of Parker Land Company property; thence along line of Parker Land Company S. 44-46 W. 311 feet to iron pin; thence along line same property S. 63-56 E. 382.3 feet to iron pin; thence S. 24-0 W. 420 feet along property of Parker Land Company to an iron pin at beginning, containing 5.33 acres, more or less, as shown by survey of R.E.
