on the south side of Birnie Street, in the City of Greenville, having the following metes and bounds according to a plat made by R. E. Dalton, Engineer, in February, 1922: Beginning at an old pipe on the south side of Birnie Street at the corner of property now or formerly belonging to the Donaldson estate, and running thence along the line of Birnie Street S. 59-40 E. 100 feet to a pipe at the corner of F. H. Irvine property; thence along the line of this said property S. 30-05 W. 207.7 feet to a pipe; thence N. 59-50 W. 100 feet to a pipe on the line of the Donaldson estate property; thence along the line of last mentioned property N. 30-05 W. 308.1 feet to the beginning corner
