*dollars per month, due quarterly* payable  
*on the 1st day of each month* beginning *March*

at the rate of... *135* per centum per annum until paid, and *monthly* annually,  
and if unpaid when due to bear interest at same rate as principal until paid, and *monthly* have further  
promised and agreed to pay ten per cent of the whole amount due for attorney's fees if said note be collected by an attorney or through legal pro-  
ceedings of any kind, reference being hereunto had will more fully appear.

NOW KNOW ALL MEN, That I *W. C. Whitworth* the said... in consideration of the said debt and sum of money aforesaid, and for the better  
securing the payment thereof according to the terms of the said note... and also in consideration of the further sum of Three Dollars to me...

in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold  
and released, and by these presents do grant, bargain, sell and release unto the said *W. C. Whitworth*  
all that piece, parcel, tract or lot of land situated in *Greenville*  
Township, Greenville County, State of South Carolina.

*known as* *lot 17* *plat of lands of H. B. Bates made for E. D. Walton, Engineer, and re- corded in Plat Book F, page 32, and having the following course and distances: Beginning at an iron pipe on the corner of Bates and Center Streets and running with Bates Street S. 55 40 E. 50 feet to iron pin, corner of lot no. 17, thence with side of said lot S. 48-30 W. 150 feet to iron pin, corner of lot no. 18; thence with line of lot no. 18, S. 55-40 W. 50 feet to iron pin at Center Street; thence with Center Street N. 48-30 E. 150 feet to the beginning.*

It is understood and agreed that the lien of this mortgage shall rank junior to the lien of the mortgage this day given by me to Julia W. Charles, Attorney, for \$700.

For value received I, W.C. Whitworth, do hereby waive priority of the lien of the within mortgage in favor of a certain mortgage for \$900.00 executed by G.A.
