NOW, KNOW ALL MEN THAT I, Edgar C. Waldrop

in consideration of the said debt and sum of money aforesaid and for the better securing the payment thereof according to the terms of the said note and also in consideration of the further sum of Three Dollars to me

in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J. E. Stark

all that piece, parcel, tract or lot of land situated in Township, Greenville County, State of South Carolina

City of Greenville, known and designated as lots Nos. 37 and 38 and a portion of lot No. 39 in the Estate of Perry C. Williams, as shown on plat of Perry C. Williams' Office for Greenville County in page 127 and having following metes and bounds: Beginning at iron pin and corner of lot No. 37 and thence with line of lot No. 37 to iron pin, joint corner of lots No. 37 and 38 and running thence with line of lot No. 30 and lot No. 31 N. 58-30 E. 100 feet to iron pin; thence along back line of lots Nos. 35 and 36 S. 31-30 E. 150 feet to beginning corner.

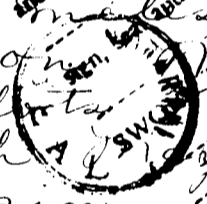
