Greenville on the Laurens Road, and having the following metes and bounds, to-wit:
Beginning at an iron pin on the Laurens Road at Glenn's corner; thence N. 33 E. 6.60 to
iron pin; thence S. 56 1/2 E. 1.51 to iron pin; thence S. 33 W. 6.60 to iron pin on Laurens
Road; thence N. 56 1/2 W. 1.51 to beginning corner.
