with interest thereon, from date at the rate of 8 per cent. per annum to be  
computed and paid semi-annually

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or  
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof,  
who may sue thereon and foreclose this mortgage, said note further to be secured by an attorney's fee of ten (10) per cent

number Seven as shown in plat Book "E", page 214, said plat made by R.E. Dalton,  
Engineer, and recorded in June 29th, 1921, said lot being located on Harvley Street and  
having dimensions as shown on above mentioned plat.
