WHEREAS, I, the said Arthur H. Mackey

in the full and just of One Thousand five hundred (\$1500.00)  
Dollars, to be paid \$500.00 one year from date, \$500.00 two years from  
date, and \$500.00 three years from date

with interest thereon, from date of this mortgage, at the rate of 8 per cent. per annum to be  
computed and paid.

until paid in full, all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or  
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof,  
who may sue thereon and for costs of this mortgage, said note further providing for an attorney's fee of ten per cent  
besides all costs and expenses of collection, to be  
added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or  
any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note,  
reference being thereunto had, as will more fully appear.

grant, bargain, sell and release unto the said Mrs. S. L. Mills

All that certain piece parcel or lot of land situate on  
the north side of Trentiss Ave. in Greenville County,  
S.C. and being known as Lot No. 2 of block 8 on plat  
of property of S. L. Mills, said plat to be recorded in Plat  
Book 9, page 171, and having the following notes and bounds  
according to said plat, to-wit:  
Commencing at an iron pipe at the northwest corner of  
Trentiss Ave. and Church Street, thence along the north  
side of Trentiss Ave. 245-27 W. 62 feet to an iron pipe  
corner of lot 210.4; thence along line of lot 210.4, N. 44-33 W.  
180 feet to an iron pipe on the south side of a 16 foot  
alley, thence along the south side of said alley N. 45-27 E.  
62 feet to an iron pipe on the west side of Church
