

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

That I, *Anna Gossett*  
of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:  
WHEREAS, I, the said *Anna Gossett*  
in and by *my am* certain note or obligation, bearing date the *25th* day of *October* 192*3*  
indebted unto The Carolina Loan and Trust Company of the City and County of Greenville, in said State (a body corporate,  
duly incorporated under the laws of such State), in the sum of *Fourteen hundred & 00/100 (\$1400.00)* Dollars,  
with interest thereon at the rate of eight per centum per annum, payable monthly from the *25th* day of *October* A. D. 192*3*,  
according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that  
I the said *Anna Gossett* shall pay or cause to be paid to the said  
Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of *January*  
192*3*, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of *Twenty three & 33/100 (\$23.33)* Dollars,  
being the regular monthly installment payable on the *Fourteen (14)* Shares of Stock, and *Twenty three & 33/100 (\$23.33)* Dollars,  
Dollars, being the monthly interest on the advance (or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the  
sum of *Twenty One & 47/100 (\$21.47)* Dollars, (*\$14.00*)  
Dollars, being the regular monthly payment on said stock and *Seven & 47/100 (\$7.47)* Dollars, being the monthly interest on balance due);  
for the next twenty months the sum of *Nineteen & 60/100 (\$19.60)* Dollars, (*\$14.00*)  
Dollars, being the regular monthly payment on said stock and *Five & 60/100 (\$5.60)* Dollars, being the monthly interest on balance due);  
for the next twenty months pay the sum of *Seventeen & 73/100 (\$17.73)* Dollars, (*\$14.00*)  
Dollars, being the monthly payment on said shares of stock and *Three & 73/100 (\$3.73)* Dollars, being the monthly interest on balance due);  
for the next twenty months pay the  
sum of *Fifteen & 86/100 (\$15.86)* Dollars, (*\$14.00*)  
Dollars, being the monthly payment on said shares of stock and *One & 86/100 (\$1.86)* Dollars, being the monthly interest on balance due.)  
Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the said Company the said *Fourteen (14)*  
shares of stock and the certificate thereof, the amount at such time paid shares by *Anna Gossett, I* to be credited as a payment upon the advance or loan made *I*, the said  
*Anna Gossett, I*  
and shall pay or cause to be paid all fines which may be duly imposed upon, or charged against *I* the said *Anna Gossett*  
said note or obligation, and the condition thereunder, reference being thereunto had will more fully appear.  
NOW, KNOW ALL MEN, That *I* the said *Anna Gossett*  
in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment hereof to the said The Carolina Loan and Trust Company,  
according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to  
the said *Anna Gossett*  
in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the signing and delivery of these Presents, (the receipt whereof is  
hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and  
Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina and described as follows:

About three miles from Greenville County Court House on  
South side of White Horse Road, Beginning at corner of  
Julia Freeman's lot on the White Horse Road; thence with  
said Road N. 58-15 W. 100 feet; thence S 50 W. 220 feet  
thence S. 58-15 E. 100 feet to Julia Freeman's line; thence  
with her line N. 50 E. 220 feet to the beginning corner,  
and being a part of the land conveyed to me by B.S.  
and Julia Freeman by deed dated January 27th, 1916,  
and recorded in Volume 38, Page 521, R. M. C. Office for  
Greenville County.
