

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

That I, Georgianna Riley of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, I, the said Georgianna Riley in and by my certain note or obligation, bearing date the 8th day of January 1924

I am indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of Two hundred fifty + 1.00 (\$ 250.00) Dollars, with interest thereon at the rate of eight per centum per annum, payable monthly, from the 8th day of January A. D. 1924, according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that

I the said Georgianna Riley shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of January 1924, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of

Six + 67/100 (\$ 6.67) Dollars, (\$ 5.00) Dollars, being the regular monthly installment payable on the Two and one half Shares of Stock, and One + 67/100 (\$ 1.67)

Dollars, being the monthly interest on the advance or loan) until there have been paid ten monthly payments, and shall for the next ten months pay the sum of Six + 33/100 (\$ 6.33) Dollars, (\$ 5.00) Dollars, being the regular monthly payment on said stock and One + 33/100 (\$ 1.33)

Dollars, being the monthly interest on balance due); for the next ten months the sum of Six + 20/100 (\$ 6.20) Dollars, (\$ 5.00) Dollars, being the regular monthly payment on said stock and One + 20/100 (\$ 1.00)

Dollars, being the monthly interest on balance due); for the next ten months pay the sum of Five + 67/100 (\$ 5.67) Dollars, (\$ 5.00) Dollars, being the monthly payment on said shares of stock and

Sixty-seven cents (\$ 0.67) Dollars, being the monthly interest on balance due); for the next ten months pay the sum of Five + 33/100 (\$ 5.33) Dollars, (\$ 5.00) Dollars, being the monthly payment on said shares of stock and

Thirty-three cents (\$ 0.33) Dollars, being the monthly interest on balance due.) Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said 2 1/2

shares of stock and the certificate thereof, the amount at such time paid shares by I to be credited as a payment upon the advance or loan made. I, the said

Georgianna Riley and shall pay or cause to be paid all fines which may be duly imposed upon, or charged against I the said Georgianna Riley

in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said note or obligation, and the condition thereunder written, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That I the said Georgianna Riley in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment hereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to me

the said Georgianna Riley in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

In the City of Greenville, Beginning on South side of Sullivan Street at Williams' corner; thence S. 18 1/2 N. to the Mc. Kenzie Line; thence with Mc. Kenzie line S. 77 1/2 E. 49 feet; thence N. 18 1/2 E. with line of Hattie & John Sullivan to Sullivan Street; thence with Sullivan about 50 feet to the beginning corner, being same lot conveyed to me by J. C. Milford, deed dated June 1st, 1920, and recorded in Volume 48, Page 349, R. M. C. Office for said Greenville County.
