

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

That I, Alice D'Oyley
of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, I, the said Alice D'Oyley
in and by my certain note or obligation, bearing date the 21st day of March 1924

am indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of One Thousand + $\frac{20}{100}$ (\$1,000.00) Dollars,
with interest thereon at the rate of eight per centum per annum, payable monthly, from the 21st day of April A. D. 1924,

according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that I the said Alice D'Oyley shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of April 1924, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of

Sixteen + $\frac{67}{100}$ (\$16.67) Dollars, (\$10.00) Dollars,
being the regular monthly installment payable on the Ten (10) Shares of Stock, and Six + $\frac{67}{100}$ (\$6.67)

Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of Fifteen + $\frac{33}{100}$ (\$15.33) Dollars, (\$10.00) Dollars, being the the regular monthly payment on said stock and Five + $\frac{33}{100}$ (\$5.33) Dollars, being the monthly interest on balance due);

for the next twenty months the sum of Fourteen + $\frac{20}{100}$ (\$14.00) Dollars, (\$10.00) Dollars, being the regular monthly payment on said stock and Four + $\frac{20}{100}$ (\$4.00) Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Twelve + $\frac{67}{100}$ (\$12.67) Dollars, (\$10.00) Dollars, being the monthly payment on said shares of stock and Two + $\frac{67}{100}$ (\$2.67) Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Eleven + $\frac{33}{100}$ (\$11.33) Dollars, (\$10.00) Dollars, being the monthly payment on said shares of stock and One + $\frac{33}{100}$ (\$1.33) Dollars, being the monthly interest on balance due.)

Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said Ten (10) shares of stock and the certificate thereof the amount at such time paid shares by I to be credited as a payment upon the advance or loan made I, the said Alice D'Oyley

and shall pay or cause to be paid all fines which may be duly imposed upon or charged against I the said Alice D'Oyley

in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said note or obligation, and the condition thereunder written, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That I the said Alice D'Oyley in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to me the said Alice D'Oyley

in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

In the City of Greenville, being Lot No. 7 of survey made by J.K. Dickson. Beginning on Nichols Street; thence with Nichols Street N. 77- $\frac{1}{2}$ W. 100 feet and 3 inches; thence S. 21- $\frac{1}{2}$ W. 123 feet; thence S. 68- $\frac{1}{2}$ E. 98 feet and 4 inches; thence N. 21- $\frac{1}{2}$ E. 150 feet to the beginning corner, less a loss of 36.7 feet wide and 113.1 feet deep, being the western part of the above described lot, conveyed by me to Crosby D'Oyley, by deed dated April 28th, 1922 and recorded in Volume 74, page 326. The above described lot is the same lot conveyed to me by J.W. D'Oyley by deed dated April 28th, 1906, and recorded in Volume 533 page 206, R.M.C. Office for Greenville County.
