

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

That I, A. G. New
of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, I, the said A. G. New
in and by my certain note or obligation, bearing date the 2nd day of January 1924

am indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of Five Thousand + 20/100 (\$5000.00) Dollars, with interest thereon at the rate of eight per centum per annum, payable monthly, from the 2nd day of January, A. D. 1924, according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that

the said A. G. New shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of January 1924, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of Eighty-Three + 33/100 (\$83.33) Dollars, (\$50.00) Dollars,

being the regular monthly installment payable on the Fifty (50) Shares of Stock, and Thirty Three + 33/100 (\$33.33) Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of Seventy-Six + 67/100 (\$76.67) Dollars, (\$50.00) Dollars, being the regular monthly payment on said stock and Twenty-Six + 67/100 (\$26.67) Dollars, being the monthly interest on balance due);

for the next twenty months the sum of Seventy + 20/100 (\$70.00) Dollars, being the regular monthly payment on said stock and Twenty + 20/100 (\$20.00) Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Sixty-Three + 33/100 (\$63.33) Dollars, (\$50.00) Dollars, being the regular monthly payment on said stock and Thirteen + 33/100 (\$13.33) Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Fifty-Six + 67/100 (\$56.67) Dollars, (\$50.00) Dollars, being the regular monthly payment on said stock and Six + 67/100 (\$6.67) Dollars, being the monthly interest on balance due.)

Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said Fifty (50) shares of stock and the certificate thereof, the amount at such time paid shares by I to be credited as a payment upon the advance or loan made to the said A. G. New

and shall pay or cause to be paid all fines which may be duly imposed upon, or charged against I the said A. G. New in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said note or obligation, and the condition thereunder written, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That I the said A. G. New in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to me the said A. G. New

in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

In the City of Greenville, on Washington Street, said lot fronting on Washington street sixty (60) feet and having a depth of one hundred sixty-five (165) feet bounded on East by lot of J. E. Robbins, on North by lot of R. J. Rowley, on West by ten (10) foot alley and on the South by Washington street and being the same lot conveyed to me by J. D. Collins and D. A. Collins by deed dated December 3rd 1923, and recorded in Volume 88, page 543, R. M. C. office for Greenville County.

I certify that the amount loaned to A. G. New was three thousand seven hundred dollars and was interest free from April 2-1924, and this indebtedness is hereby reduced from five thousand to said \$3700.
