That I, Sallie Lou Williams
of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:
WHEREAS, I, Sallie Lou Williams, the said
in and by my certain note or obligation, bearing date the 30th day of April 1924
I am indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate,
duly incorporated under the laws of such State), in the sum of Four hundred + 2/100 (\$400.00) Dollars,
with interest thereon at the rate of eight per centum per annum, payable monthly, from the 30th day of April A. D. 1924,
according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that
I, the said Sallie Lou Williams shall pay or cause to be paid to the said
Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of May
1924, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of Six + 67/100 (\$6.67) Dollars,
being the regular monthly installment payable on the Four (4) Shares of Stock, and Two + 67/100 (\$2.67) Dollars,
Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the
sum of Six + 13/100 (\$6.13) Dollars, being the regular monthly payment on said stock and Two + 13/100 (\$2.13) Dollars, being the monthly interest on balance due);
for the next twenty months the sum of Five + 60/100 (\$5.60) Dollars, being the regular monthly payment on said stock and One + 61/100 (\$1.60)
Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Five + 07/100 (\$5.07) Dollars, being the monthly payment on said shares of stock and
One + 07/100 (\$1.07) Dollars, being the monthly interest on balance due); for the next twenty months pay the
sum of Four + 53/100 (\$4.53) Dollars, being the monthly payment on said shares of stock and Four + 00/100 (\$4.00) Dollars, being the monthly interest on balance due.)
Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said Four (4)
shares of stock and the certificate thereof, the amount at such time paid shares by I to be credited as a payment upon the advance or loan made I, the said

hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and
