That I, Josephine Schumate
of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, I, the said Josephine Schumate
in and by My certain note or obligation, bearing date the 11th day of June 1924

am indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate,
duly incorporated under the laws of such State), in the sum of One Thousand & 7/100 (\$1,000.00) Dollars,
with interest thereon at the rate of eight per centum per annum, payable monthly, from the 11th day of June A. D. 1924,

according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that
the said Josephine Schumate shall pay or cause to be paid to the said

Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of June,
1924, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of Sixteen & 67/100 (\$16.67) Dollars, (16.67) Dollars,

being the regular monthly installment payable on the Five (5) Shares of Stock, and Five & 67/100 (\$5.67)
Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the

sum of Fifteen & 33/100 (\$15.33) Dollars, (15.33) Dollars, being the regular monthly payment on said stock and Five & 33/100 (\$5.33)
Dollars, being the monthly interest on balance due); for the next twenty months the sum of Fourteen & 33/100 (\$14.33) Dollars,

(14.33) Dollars, being the regular monthly payment on said stock and Four & 33/100 (\$4.33)
Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Thirteen & 33/100 (\$13.33)
Dollars, (13.33) Dollars, being the regular monthly payment on said stock and Three & 33/100 (\$3.33)

Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Twelve & 33/100 (\$12.67)
Dollars, (12.67) Dollars, being the regular monthly payment on said stock and Two & 67/100 (\$2.67)
Dollars, being the monthly interest on balance due); for the next twenty months pay the

sum of Eleven & 33/100 (\$11.33) Dollars, (11.33) Dollars, being the regular monthly payment on said stock and One & 33/100 (\$1.33)
Dollars, being the monthly interest on balance due.) Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said Five (5)
