

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

That I, J. O. Allen of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, I, J. O. Allen, the said J. O. Allen in and by J. O. Allen certain note or obligation, bearing date the 5th day of July 1924

indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of Sixteen Hundred and 20/100 (\$1600.00) Dollars, with interest thereon at the rate of eight per centum per annum, payable monthly, from the 5th day of July A. D. 1924, according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that I

the said J. O. Allen shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of July 1924, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of Twenty-six and 67/100 (\$26.67) Dollars, (\$16.00) Dollars,

being the regular monthly installment payable on the Sixteen (16) Shares of Stock, and Ten and 67/100 (\$10.67) Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of Twenty-four and 53/100 (\$24.53) Dollars, (\$16.00) Dollars,

Dollars, being the regular monthly payment on said stock and Eight and 53/100 (\$8.53) Dollars, being the monthly interest on balance due); for the next twenty months the sum of Twenty-two and 40/100 (\$22.40) Dollars, (\$16.00) Dollars, being the regular monthly payment on said stock and Six and 40/100 (\$6.40) Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Twenty and 27/100 (\$20.27) Dollars, (\$16.00) Dollars,

Dollars, being the monthly payment on said shares of stock and Four and 27/100 (\$4.27) Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Eighteen and 13/100 (\$18.13) Dollars, (\$16.00) Dollars, being the monthly payment on said shares of stock and Two and 13/100 (\$2.13) Dollars, being the monthly interest on balance due.)

Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said Sixteen (16) shares of stock and the certificate thereof, the amount at such time paid shares by J. O. Allen to be credited as a payment upon the advance or loan made by the said J. O. Allen and shall pay or cause to be paid all fines which may be duly imposed upon, or charged against J. O. Allen the said J. O. Allen

in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said note or obligation, and the condition thereunder written, reference being thereunto had will more fully appear. NOW, KNOW ALL MEN, That I, J. O. Allen, the said J. O. Allen in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to me

the said J. O. Allen in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

In Ward two (2) on Thompson Street, being Lot No. One (1) of Sam B. McDaniel Estate, plat made by R. E. Dalton. Beginning on Thompson Street 119 feet from the southeast corner of the intersection of Thompson and Ann Streets and running thence N. 78-36 E. 112 feet to corner of Lot No. 3; thence N. 10-21 W. 54 feet; thence S. 78-27 W. 106.6 feet to a pin on Thompson Street; thence along line of Thompson Street S. 41-34 E. 54 feet to the beginning corner, being same lot conveyed to me by E.
