in the full and just sum of *Two Thousand*  
Dollars, to be paid *December 10th, 1924*

with interest thereon, from *date* at the rate of *7* per cent. per annum, to be  
computed and paid *annually*

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or  
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof,  
who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of *ten per cent of the amount due* besides all costs and expenses of collection, to be  
added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or  
any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereunto had, as will more fully appear.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do  
grant, bargain, sell and release unto the said *A. L. Dawling and Nora W. Cooper Guardians*

All that certain piece, parcel or lot of land situated  
lying and being in Greenville Township, Greenville  
County, State of South Carolina, and being more  
and designated as lot no. 9 of the subdivisions  
known as Augustus Circle, as shown on a plat  
of records in the R. M. C. Office, for Greenville, County  
South Carolina in plat Book 1 page 25 and having  
according to said plat, the following metes and  
bounds, to-wit: Beginning at a station pin on the  
north west corner of Paris Road and West Augusta  
Drive and running thence with Paris road N. 16-20 E.  
160 feet to iron pipe thence with line of lot seven  
and eight S. 55-15 one hundred feet to iron pipe  
thence with the joint lines of lots 7 and 10 S.
