SEND GREETING:

WHEREAS, *W. D. Worreman*, the said *W. D. Worreman*
in and by *my* certain *Procurator* note in writing, of
even date with these presents, *me* well and truly indebted to

in the full and just sum of *Five Thousand and no/100*
Dollars, to be paid *January 1st, 1929, with recall to anticipate*
either wholly or in parts at any time before
maturity

with interest thereon, from *Jan 1st 1924 until paid* the rate of *six* per cent. per annum, to be
computed and paid *semi-annually*
until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof,
who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of

Five percent of amount due besides all costs and expenses of collection, to be
added to the amount due on said note, to be collectible *in part* thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or
any part thereof, be collected by an attorney or by legal proceedings of *any* kind (all of which is secured under this mortgage); as in and by the said note,
reference being thereunto had, as will more fully appear.

NOW, KNOW ALL MEN, That *W. D. Worreman*
in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said *H. Rush*

according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to *me*, the said *W. D. Worreman*
in hand well and truly paid by the said *J. H. Rush*

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do
grant, bargain, sell and release unto the said *J. H. Rush, his heirs and assigns*
All that lot of land situate near North west intersection of Buncombe and Laurens Streets,
in the City and County of Greenville, South Carolina, designated as Lot No. 17 of plat
of *Rush Brothers*, as shown by R.E. Dalton plat, January 1924, and more particularly
described as follows: Beginning at a point on Buncombe Street, at corner of lot No. 16,
which is at the western edge of a seventeen inch brick wall and runs thence along said
edge of said wall N. 20.04 E. 73.5 feet; thence N. 69.07 W. 20 feet; thence S. 20.04 W.
59.58 feet to Buncombe Street at a drill hole; thence S. 34.30 E. 24.53 feet to beginning
corner.

Being a part of the lot conveyed to me by J.H. Rush, deed dated Jan. 31, 1924, to be
recorded, and this mortgage is given to secure balance of purchase money.
