interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof,  
who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of ten per cent besides all costs and expenses of collection, to be

land situate, lying and being in the State and County aforesaid, in Glassy Mountain Township,  
and having the following metes and bounds, to-wit: Beginning at a stone on Creek and running  
thence N. 62 E. 6.00 chs. to a stone; thence N. 2-30 E. 11.90 chs. to stone on Creek; thence  
N. 15-30 E. 7.15 chs. to a stone; thence N. 54 E. 8.00 chs. to a stone; thence N. 13 W. 8.28  
chs. to a stone; thence N. 78-30 E. 6.37 chs. to a stone on creek; thence up the meanderings  
of said Creek to a Hickory tree; thence N. 86-30 W. 13.00 chs. to a stake; thence S. 5 E. 49-40
