any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note,

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do  
grant, bargain, sell and release unto the said Henry P. McGee, his heirs and assigns, all that certain

piece, parcel or lot of land, lying and being in Butler Township and State aforesaid  
having the following metes and bounds and designated as Tract No. 2 of the Josie L. Floyd  
lands: Beginning at an iron pin in road corner of tract No. 1 and running thence with tract  
No. 1, approximately S. 82.05 E. 1803 feet; thence S. 38-30 E. 190 feet to a stone; thence  
S. 14.50 W. 588 feet to a stake corner of tract No. 3; thence with tract No. 3 N. 88 S.W.  
1545 feet to iron pin in road; thence with road N. 1230 W. 935-4 feet to the beginning
