THIS DEBT HEREBY SECURED IS PAID IN FULL AND THE LIEN OF THIS INSTRUMENT IS SATISFIED THIS 29th DAY 1928

with interest thereon from the date of the making of this mortgage at the rate of eight per cent (8%) until paid in full; the interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and note further providing for an attorney's fee of ten per cent of the amount due, besides all costs and expenses of collection, to be added to the amount due on said note and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereunto had, will more fully appear.

NOW KNOW ALL MEN, That the said Mortgagor in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said Mortgagee according to the terms of the said note, and also in consideration of the further sum of Three Dollars to the said Mortgagor in hand well and truly paid by the said Mortgagee, at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain and release unto the said Mortgagee, and his Heirs and Assigns, forever, all and singular that certain piece, parcel, lot or tract of land situate, lying and being in Greenville Township Greenville County, State aforesaid,

On the South side of McBee Spring Road, and having the following metes and bounds to-wit: Beginning at the corner of lot heretofore conveyed by Lammie C. Simpson to E. C. Wass and running thence with said lot S. 26-31 E. 194 feet, more or less to a point thence N. 62-27 E. 60 feet to a point in line of lot now owned by Lammie C. Simpson, thence N. 26-13 W. 194 feet more or less to McBee Spring Road; thence with said McBee Spring Road S. 56-12 W. 60 feet to the beginning corner, being a part of lots 12 and 13 of the G. D.
