And the said Mortgagor id agree to insure the house and buildings on said lot in a sum not less than Four Thousand Dollars (in a company or companies satisfactory to the mortgagee id), and keep the same insured from loss or damage by fire, and assign the policy of insurance to the said mortgagee id, and that in the event that the mortgagor shall at any time fail to do so, then the said mortgagee may cause the same to be insured in his name and reimburse himself
