with interest thereon, from *John G. Hartnett*, at the rate of *8* per cent. per annum, to be computed and paid *John G. Hartnett* *in full* *May 1924*

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note, to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of *16 4/10*

besides all costs and expenses of collection, to be added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereunto had, as will more fully appear.

All that one acre ~~and~~ piece of land lying and being in the State and County aforesaid in the town of Greenville, having the following corners and bounds to wit: Beginning at a stake on Nine Street corner of Lot #2 and running thence N. 15° 40' E. 60 feet to a stake on Nine Street corner Lot #5, thence with the line of the ~~old~~ lot #5, N. 12.30 W. 150 feet to a stake corner Lot #3, thence with the line of the said lot #3 S. 72.21 E. 150' feet to the beginning corner and hence all of lot #4 and a flat of land known as Westmoreland Circle and being the same lot of land deeded to me by P.
