SEND GREETING:

WHEREAS, I, Jesse H. Morgan, the said Jesse H. Morgan
in and by my certain promissory note in writing, of
even date with these presents, well and truly indebted to

Lois T. Holly
in the full and just sum of Two hundred thirty-eight and 37/100
Dollars, to be paid Nov. 1st, 1924.

with interest thereon, from date at the rate of 8 per cent. per annum, to be
computed and paid annually

until paid in full, all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof,
who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of

fifty dollars besides all costs and expenses of collection, to be
added to the amount due on said note to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or
any part thereof, be collected by any attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note,
reference being thereunto had, as will more fully appear.

NOW, KNOW ALL MEN, That I, Jesse H. Morgan, the said Jesse H. Morgan
in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said

according to the terms of said note, and also in consideration of the further sum of Three Dollars to me, the said

Jesse H. Morgan
in hand well and truly paid by the said

Lois T. Holly at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents, do grant,
bargain, sell and release unto the said Lois T. Holly: All that certain piece and parcel of land situated,

lying and being in the County of Greenville, State of South Carolina, in Grove Township, and
having the following metes and bounds: Beginning on an iron pin and running S. 41-3/4 E.
6.50; thence N. 33 W. 25.00 to an iron pin; thence S. 33 W. 22.50 to the beginning corner,
containing 6.6 acres, more or less, and adjoining lands of Jerry McKenzie, Jessie H.-
Morgan and M.W. Bishop.

Being the same land conveyed to me by V.R. Jenkins, by deed dated Feb. 5, 1913, and recorded
in the R.M.C. Office for Greenville County in Vol. 41, page 552.
