All that certain piece parcels or lot of land situate, lying and being in the state and County aforesaid, in the town of Greenville, having the following lines and bounds described; Beginning at a stone on the South side of James Street corner of lot no. 8 and, running thence with the line of lots nos. 7 and 8 S. 6-30 W. 221.5 feet to a stake on alley, named N. 76-30 W. 57.4 feet to a stake corner of lot no. 6, thence with line of lot no. 6 S. 6-30 W. 218 feet to a stone on the South side of James St.; thence with said street S. 75 E. 60 feet to the beginning corner, and being designated as lot no. 7 known as "Cannon Park" prepared by A.
