Henderson his Heirs and Assigns, from and against me and my Executors, Administrators and Assigns, and every person whomsoever lawfully claiming, or to claim the same, or any part thereof.

And the said Mortgagor..... agree... to insure the house and buildings on said lot in a sum not less than Five Hundred Dollars (in a company or companies satisfactory to the mortgagee.....), and keep the same insured from loss or damage by me and assign the policy of insurance to the said mortgagee....., and that in the event that the mortgagor..... shall at any time fail to do so, then the said mortgagee..... may cause the same to be insured in his own name and reimburse himself the premium and expense of such insurance under this mortgage, with interest.

If at any time any part of said debt, or interest thereon be past due and unpaid..... hereby assign the rents and profits of the above described premises to said mortgagee..... or.....
