Successors Heirs and Assigns, from and against Ourselves and Our
Heirs, Executors, Administrators and Assigns, and every person whomsoever lawfully claiming, or to claim the same, or any part thereof.

And the said Mortgagor S. agree to insure the house and buildings on said lot in a sum not less than the amount of this
indebtedness Dollars (in a company or companies satisfactory to the mortgagee.....), and keep the same insured from loss or damage by

PROVIDED ALWAYS, NEVERTHELESS, and it is the true intent and meaning of the parties to these Presents, that if We
the said mortgagor....., do and shall well and truly pay or cause to be paid, unto the said mortgagee....., the said debt or sum of money aforesaid, with interest
thereon, if any be due, according to the true intent and meaning of the said note, then this deed of bargain and sale shall cease, determine, and be utterly null
and void; otherwise to remain in full force and virtue.
