WHEREAS, I the said W. H. Green

in and by my certain promissory note in writing of even date with these presents well and truly indebted to GREENVILLE BUILDING AND LOAN ASSOCIATION, a corporation, incorporated under the laws of the State of South Carolina, in the full and just sum of Three hundred and (\$300.00) only

DOLLARS,

to be paid on or before the date when the series of the Capital Stock of the said GREENVILLE BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent. per annum, payable weekly on or before Saturday night of each and every week until paid in full; and if I fail to pay said interest or to comply in all respects with the Constitution and Laws of said Association, for the space of thirty days, then said debt shall become immediately due and payable, together with all interest, fines and expenses, and all amounts advanced by the said Association on the within described property, by way of taxes or insurance, the same to be added to the amount due on said note and to be collectible as part thereof, together with an attorney's fee of ten per cent. if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof be collected by an attorney, or legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being hereunto had, will more fully appear.

ING AND LOAN ASSOCIATION all that certain parcel, piece or lot of land in the State and County aforesaid, being Lot No. 3 of the sub-division known as Verner Hill and having the following metes and bounds, to-wit:

Beginning at an iron pin on the north side of Riverside Road and running thence N. 10-1/2 E. 150 feet to an iron pin; thence N. 65 W. 60 feet to an iron pin; thence S. 11 W. 150 feet to an iron pin on Riverside Rd. thence S. 65 E. 70 ft. to the beginning corner.
