THIS INDENTURE, made the 1st day of October in the year one thousand nine hundred and twenty nine between J Albert Bramlett

part of the first part, and THE EQUITABLE LIFE ASSURANCE SOCIETY OF THE UNITED STATES, a corporation organized and existing under the laws of the State of New York, having its principal office at Number 120 Broadway, in the Borough of Mahattan, of the City of New York, party of the second part; the said party of the first part being hereinafter known and designated as the MORTGAGOR, and the said party of the second part being hereinafter known and designated as the MORTGAGEE;

WITNESSETH: WHEREAS, the said mortgagee has issued to J Albert Bramlett

its certain policy of insurance, bearing register date the first day of October, 1929, and numbered 7791608 agreeing to pay to the beneficiary therein named upon receipt of due proof of the death of the insured, provided premiums have been duly paid and said policy be then in force and be then surrendered properly released, the sum of Two Thousand

(\$ 2000.00) DOLLARS, all in accordance with the terms and conditions of said policy.

WHEREAS, the said mortgagor is justly indebted to the said mortgagee in the sum of Two Thousand

(\$ 2000.00) DOLLARS, in gold coin of the United States of America, of the present standard of weight and fineness, secured to be paid, together with the premiums on said policy of insurance, by a certain bond or obligation bearing date herewith, conditioned for the payment thereof at the principal office of the said mortgagee in the City of New York in One Hundred Twenty

each of the sum of Twenty Six equal monthly installments,

(\$ 26.00) DOLLARS, gold coin as aforesaid, payable in advance on the first day of each successive calendar month,

beginning on the first day of October, 1929; and each such installment, except the first, which does not include interest, including:

(b) Interest at the rate of six per centum per annum, duly discounted, on the monthly decreasing balance of said principal sum which will remain unpaid on said loan after the payment of each of the said monthly installments; and

(c) The monthly premium on said policy of life insurance, it being in said bond expressly agreed that the whole of said principal sum, or the balance thereof from time to time outstanding, shall become due after default in the payment of any one of said installments, or of the taxes, assessments or water rates, as thereinafter provided, anything therein to the contrary notwithstanding.

NOW, THIS INDENTURE WITNESSETH, that the mortgagor, for the better securing the payment to the said mortgagee of the said sum of money mentioned in the condition of the bond or obligation as aforesaid, with interest thereon, and also for and in consideration of the sum of One Dollar to the mortgagee, in hand paid by the mortgagor, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents do hereby grant, bargain, sell and convey unto the said mortgagee, its successors and assigns, forever:

all that certain piece, parcel or lot of land situated lying and being in the City of Greenville, County of Greenville, State of South Carolina, on the north side of Harley Street known and designated as lot no 3a of the property of N. M. Jordan and F. H. and J. G. Cunningham. Plat thereof being recorded in the R. M. C. Office for Greenville County in Plat Book "E" at page 214, and having, according to said plat, the following metes and bounds, to-wit:-

Beginning at an iron pin 150 feet from the northeast intersection of Rutherford and Harley Streets, joint corner of lots nos. 2 and 3a, and running thence along Harley Street S. 84-04 1/2 feet to an iron pin, joint corner of lots nos 3b and 3a; thence along the joint line of said lots, N. 1-12 E. 108.5 feet to an iron pin, near joint corner of said lots; thence N. 87-05 1/2 E. 50 feet to an iron pin; thence S. 1-12 W. 108.5 feet to the point of beginning.
