AND LOAN ASSOCIATION *all that lot of land in Greenville Township,*

*Greenville County, South Carolina, on what is known as the White Horse Road, and being known and designated as lots nos. 1 and 2 of a subdivision of the old Looper-Town property. According to a plat of said property recorded in R. M. C. Office for Greenville County in plat Book E, page 48, having the following metes and bounds: Beginning at a stake on the White Horse Road common corner of lots 2 and 3, and running thence along the line of lot no. 3, S. 69.00 W. 350 feet to a stake; thence S. 21-30 E. 100 feet to a stake; thence N. 69.00 E. 350 feet to a stake on White Horse Road; thence along said White Horse Road N. 21-30 W. 100 feet to the beginning corner, being the same conveyed to me by J.
