WHEREAS, *W.C.C.*, the said *H.H. Hill and A.L. Sammons*

in and by *W.C.C.* certain promissory note in writing, of even date with these presents *W.C.C.* well and truly indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation incorporated under the laws of the State of South Carolina, in the full and just sum of *one thousand 00/100* Dollars,

to be paid on or before the date when the *3/1st* Series of the
