WHEREAS, *J. J. Morris* the said.....

in and by *my* certain promissory note in writing, of even date with these presents, *am* well and truly indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation incorporated under the laws of the State of South Carolina, in the full and just sum of *Four Hundred and no/100* Dollars, to be paid on or before the date when the *26th* Series of the *Installment*

..... Stock of the said AMERICAN BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent. per annum, payable weekly, on or before Saturday night of each and every week, until paid in full; and if.....

fail to pay said interest or to comply in all respects with the By-Laws of said association, for the space of thirty days, then said debt shall become immediately due and payable, together with all interest, fines and expenses, and all amounts advanced by the said Association on the within described property, by way of taxes or insurance, the same to be added to the amount due on said note and to be collectible as part thereof, together with an attorney's fee of ten per cent. if the same be placed in the hands of an attorney for collection or if said debt, or any part thereof be collected by an attorney, or legal proceedings of any kind (all of which is secured under this mortgage, as provided in and by the said note, reference being thereunto had, will more fully appear.

NOW, KNOW ALL MEN That *J. J. Morris* the said.....

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said AMERICAN BUILDING AND LOAN ASSOCIATION, according to the terms of the said note and also in consideration of the further sum of Three Dollars, to *me* the said *J. J. Morris*

in hand well and truly paid by the said AMERICAN BUILDING AND LOAN ASSOCIATION, at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said AMERICAN BUILDING AND LOAN ASSOCIATION

In Greenville Township, near the city of Greenville as shown on the *State of Judson Mills* and known as Edgemont being known and designated on said *plat* as *lot # 22*. Said lot has a frontage on *Edgemont Avenue* of 60 feet and a depth of *150* feet to the property of Judson Mills, as by reference to said *plat* will more fully appear.

It is understood and agreed that this is the same lot of land now covered by my mortgage to the American Building and Loan Association for the original amount of \$500.00, mortgage dated February 2, 1923 and recorded in Volume 126 at Page 207, and that the within mortgage is to rank concurrent with above mentioned mortgage and that both shall be held to secure payment of this date.

The above described land is the same conveyed to the mortgagee by Judson Mills on the 6th day of October 1922, deed recorded in office of Register of Mesne Conveyances for Greenville County in Book 72, page 318.
