WHEREAS, *I*, the said *C. M. Harling*

in and by *myself* certain promissory note in writing, of even date with these presents *and* well and truly indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation incorporated under the laws of the State of South Carolina, in the full and just sum of *Eleven hundred fifty (\$1150.00)* Dollars, to be paid on or before the date when the *28th* Series of the

Bates, property as shown on plat of said property recorded in the office of the R. M.
